5 I seek a TPO against former girlfriend and County Employee Tracey Hietikko based
6 on e-mails Tracey has sent me and based on an investigation into Tracey's actions
7 at her work. Tracey is currently on paid administrative leave pending investigations ~~and~~
8 Ever since my new girlfriend moved into my house ^{July 06} Tracey has been stalking and
9 harassing me with e-mails at work, sexually explicit phone calls at home, driving
10 by my house and calling my personal & work phones daily and hanging up. On 9/2/06
11 (my birthday) Tracey called me and stated "I hope you know where your dogs are" and hung up
12 on me. I have never seen my dogs of 12 years again. A neighbor found the collars in a lot
13 that Tracey and myself thought was nice. About 2 weeks ago, a friend called me and said a profile of
14 me with his picture on it was on Watch.com. Tracey has the picture of him and there was information
15 that only Tracey would know about in the profile. Tracey took me to small claims court (last)
16 on 10/16/06 and asked for mother's day brunch money back. Most recently, my girlfriend's child (9 yrs old)
17 had a camera in his backpack. When asked where he got it he stated Tracey had come over to her
18 ex-husband's house (whom my girlfriend has a TPO against) and asked that he take pictures of our
19 inside of our house for her. Tracey has a history of being harassing and stalking of ex-
20 boyfriends. A TPO was filed against her (CASE # CVDZ-02302) previously. She has also been
21 arrested after being caught on surveillance tape slashing her ex-boyfriend's tires and spray
22 painting his garage door. My girlfriend's kids live with me and if Tracey is terminated from
23 her employment because of her actions against me and my girlfriend, she may be violent.
